

(b) Such action shall thereafter be ratified by a majority of all the branches belonging to the Association.

Provided, however, that the use of the name of the Association for the support of a policy may be authorized by affirmative vote of two-thirds of the members of the Board of Directors.

**ARTICLE XIV**  
**AMENDMENTS**

These By-Laws may be amended at any meeting of the State Division by a majority vote of the members present and voting thereon, provided notice of the proposed amendment, together with a copy thereof, shall have been sent to each Branch in membership and to the representatives of the members-at-large at least thirty days previous to the meeting at which such amendment is to be acted upon.

**ARTICLE XV**  
**RULES OF ORDER**

Robert's Rules of Order Revised shall be authority for all parliamentary procedure of this organization when not covered by these By-Laws.
