Document No. 28—Report of the ORGANIZATION COMMITTEE was read by D. S. C. R., Albert Springer, Sr., as follows:

To the Officers and Delegates of the 50th Annual Session, F. of A.

Brethren:

Your Committee on Organization desires to render an accounting of its stewardship of this necessary and vital part of our Order for the past year.

From May 1, to September 30, 1938 there were initiated 142 members or an average of 28 and $\frac{2}{5}$ members per month, during which time no prizes were offered.

From October 1 to December 31, 1938 there were initiated 109 members or an average of $36\frac{1}{8}$ members per month during which

time a prize of \$2.00 per member was offered.

During January, 1939, 26 members were initiated without any prize being offered, except to Special Deputy Organizers as noted below.

From February 1 to April 30, 1939, 242 candidates were initiated or an average of 80 $\frac{2}{3}$ members per month, during which time \$2.00 per member was offered after the first three initiated.

From the period of December 1, 1938 to January 30, 1939, an additional offer was made, that by the appointment of a Special Deputy Organizer for any Court an extra \$3.00 would be given for each candidate initiated. This offer was extended from February 1 to April 30, 1939.

During the time no prizes were offered, the average initiation was 28 $\frac{2}{5}$ members per month. During the time \$2.00 only was offered the average was 31 members per month and during the time \$5.00 was offered the average was 61 members per month. In speaking to members we refer to beneficial only.

This seems to clearly indicate that prizes are a stimulus in prompting members and Courts to use greater effort in the securing of members.

We must bear in mind that prizes are a form of advertising and advertising is necessary in any line of business. Fraternal Organizations are as much a business as any other form of endeavor; and only those that make a real effort will be able to survive over their competitors. We sincerely hope that the delegates will bear this in mind when legislating income for the Organization Fund.

In asking for the appointment of Special Deputy Organizers by the Chief Ranger of each Court, 32 Chief Rangers responded, 27 did not. We can safely say that this 45 per cent of Chief Rangers that did not respond represents just that much lack of co-operation that retards the advancement of our Order. If a full co-operation had been given, we would most likely have returned with a gain in membership instead of a loss, small as it was. We must have officers that will obey the mandates of the Grand Court and those that are elected or appointed to carry out its duties in the interim.

We desire to express our thanks to those drill teams that answered our call for service.

We also desire to thank those Courts that made gains in membership and to those members that responded to the call by securing new members for their Court.

We are happy to report that Court Roma No. 253 of Pittsburg is the winner of the "Klinger" Trophy for the first 25 members initiated. They are also the winner of the "Brusatori" Trophy for the largest net gain in membership. Court Livermore No. 77 is the winner of the "O'Shaughnessy" Trophy for the largest number of reinstatements. We offer our congratulations to these Courts and look forward to their carrying on in this laudable work.

Our financial report will be found on page 18 of the Advanced Reports.

The law passed at the last Grand Court, imposing a fee of \$2.00 for each candidate initiated, caused confusion and dissatisfaction and should be eliminated.

Further confusion was unintentionally caused by leaving the Grand Chief Ranger and Grand Secretary without voice or vote on the Organization Committee by the law passed at the last session. This should also be corrected by legislation.

The Committee desires to thank the Grand Chief Ranger for the opportunity to serve and trust that our efforts may have proven of some benefit.

BE IT RESOLVED, By the Grand Court of California, in Convention assembled:

That the delegates elected to the 1939 Session of the Supreme Court be instructed to present to the said Supreme Court and work for the adoption of the following amendment to the Supreme Court Constitution and General Laws of the Foresters of America, to wit:

Add to Section 125 thereof the following words: "No Past Grand Chief Ranger or Past Supreme Chief Ranger shall receive mileage or per diem for attendance at the Grand Court Sessions unless he shall have attended at least one-third of all of the regular meetings of his Court during the preceding calendar year. Attendance at the regular meeting of a Court other than his own may be made a substitute for the above. Proof of such attendances shall be presented to the Grand Court conventions before a warrant may be drawn for the payment of such mileage or per diem."

Document No. 31—Report of the COMMITTEE ON STATE OF THE ORDER as follows:

To the Officers and Members
Grand Court, F. of A., in
Convention assembled:

Your Committee on State of the Order respectfully recommends that the resolution (Document No. 30) referring to mileage and per diem for Past Grand Chief Rangers and Past Supreme Chief Rangers, be not adopted for the following reasons:

First: We believe it ill advised to instruct our Supreme Delegates on this subject.

Second: We believe that the enactment of such legislation would be inimical to the best interests of the various grand jurisdictions throughout the United States. The presence of Past Grand and Past Supreme Chief Rangers at our Grand Court sessions indicates in itself an interest in the welfare of our Order, which we believe should be encouraged to the utmost.

Document No. 32--Report of the COMMITTEE ON LAWS, as follows:

To the Grand Chief Ranger and Delegates
Dear Sirs and Brothers:

Your Committee on Laws begs leave to report as follows:

Your Committee has given serious consideration to the amendments to the Constitution and General Laws of the Grand Court and more particularly described as Document No. 2 wherein it refers to the Organization Fund and the amendments to Article 16. (See pages 21 and 22 of this Report.)

Your Committee feels that these amendments dealing with this important branch of our Order and in particular Sections 1 to 7 inclusive of the proposed amendments to Article 16 of the Constitution and General Laws of the Grand Court, if adopted would constitute an extreme change in the present setup of our Organization Department.

Certain sections of the proposed amendments if adopted would conflict with the existing Constitution and General Laws of the Supreme Court. For example, Section 6 of the proposed amendments would give to the Organization Committee power to receive and demand the resignation of Subordinate Court Officers and cause the nomination, election and installation of such officers; and is in violation and contra to Section 152, et. sec. of the Constitution and General Laws of the Supreme Court.

Section 4, subdivision A of the proposed amendments would confer complete and original jurisdiction over all of the Courts . . . , which your Committee feels is beyond the province of any Committee.

Further your Committee feels that the existing laws providing for the appointment to the Organization Committee of non-members of the Executive Council is preferable to Section 3 of the proposed amendments, where in it states that the Grand Chief Ranger, Grand Sub-Chief Ranger and Grand Secretary and five members of the Grand Court would constitute the Organization Committee.

The Committee also feels that the five year provision set forth in the proposed amendments is too long a term for membership on said committee.

Your Committee also feels that in view of the confusion and dissatisfaction caused by the provision of the present laws requiring all Courts to pay into the Organization Fund the sum of \$2.00 for each member initiated, that therefore, Section 5 of the proposed amendments if adopted would add to such confusion and dissatisfaction.

Your Committee further believes that the last sentence of Section 7 of the proposed amendments granting mileage to members

of the Organization Committee to all sessions of the Grand Court would cause needless expense to the Order.

In view of the above your Committee recommends that the proposed amendments to wit: Sections 1 to 7 inclusive to Article 16 of the Constitution and General Laws of the Grand Court be not adopted, and that Sections 1, 2 and 3 of Article 16 be not repealed.

Your Committee recommends that that portion of Document No. 2 proposing an amendment to Section 2 of Article 7, page 15, third line, by striking out the words "August and October" and substituting "September," be adopted. (See page 22 of this Report.)

Your Committee also recommends that that portion of Document No. 2 proposing an amendment to Section 3, Article 13, page 28 by striking out after the word weeks "and should his illness continue he shall receive \$5.00 for the following ten weeks" be adopted. (See page 22 of this Report.)

Your Committee also recommends that that portion of Document No. 2 proposing an amendment to Section 2, Article 14, page 29, as set forth in said proposed amendment be adopted. (See page 22 of this Report.)

Your Committee also recommends that Document No. 2 to amend Article 3, Section 1, page 4 and Article 4, Section 1, page 5 and Article 7, Section 1, page 15 be not adopted. (See pages 22 and 23 of this Report.)

Your Committee also recommends that Document No. 2, amending Article 16 of the Constitution and Laws of the Grand Court, Section 2, page 34, line one, Section 2, page 34, line 4, Section 2, page 34, line 8, Section 3, page 34, line 2, Section 3, page 34, line 4, Section 4, page 34, line 3 be not adopted. (See page 20 of this Report.)

Your Committee also recommends that Document No. 3, amending Section 5, Article 6, page 12 of the Constitution and Laws of the Grand Court be not adopted. (See page 51 of this Report.)

Your Committee also recommends that Document No. 3, and that portion thereof calling for the repeal of Section 9, Article 8 of the Grand Court Laws be adopted. (See page 51 of this Report.)

Your Committee also recommends that Document No. 4 amending Article 13 of Section one of the Constitution and Laws of the Grand Court be not adopted. (See page 51 of this Report.)

Your Committee also recommends that Document No. 2, referring to seating of Chief Rangers and Junior Past Chief Rangers, be not adopted. (See pages 21 and 22 of this Report.)

Your Committee also recommends that Document No. 13 be referred back to the proper committee as this committee has no jurisdiction over the matter. (See page 55 of this Report.)

Your Committee also recommends that Document No. 15, proposing an amendment to Article 6, Section 9, page 14, line 2 be not adopted. (See page 56 of this Report.)
