Freshman-Sophomore


The question debated was that of State Prohibition. The Sophomores upheld the affirmative and the Juniors the negative side of the question.

This contest was even closer than the Freshman-Sophomore debate, but the judges unanimously gave the decision to the Sophomore class. The Sophomores were jubilant over this victory.

Senior-Sophomore

The final—Senior-Sophomore debate for the championship of the school will be held on May 22 between the Sophomore and Senior teams.

The final debate deciding the championship of the school has not as yet been held at the time this annual goes to print.

Convention of the Debating League of California

On April 4 the Debating League of California held its thirty-second semiannual convention in the Auditorium of the Lodi Union High School. This was one of the most interesting events of the school year.

There were present about thirty delegates from the schools of the League, representing Lowell, Lick, Lux, Humboldt, Stockton, and Lodi Union High Schools.

The fine training received from debate was plainly shown at the business meeting, which lasted until noon. Lively discussions of points of order interspersed transaction of League business and created much enthusiasm.

An excellent banquet was prepared and served at noon by the domestic science class under the able supervision of Miss Goddard. During the banquet toasts were offered by the officers of the league and members of the faculty of the various schools. Mr. Snider, president of the league, acted as toastmaster.

An extemporaneous debate was held in the afternoon. In this contest Lodi was represented by Miss Limbaugh. The question to be debated was not made public until two hours prior to the contest. It was, "Resolved, that all cities in the United States of 5000 inhabitants and over, should adopt the commission form of government." Sides were chosen by lot. It fell to Lodi and Lowell to defend the negative, and Humboldt and Lick the affirmative. Lowell, Lick, and Humboldt were represented by experienced debaters; but Miss Limbaugh of Lodi won the contest by her superior argument.

The enthusiasm of the school was unbounded when the medal was presented. In the evening the delegates were entertained by a reproduction of the Senior play, "Trelawney of the Wells." The Debating society appreciates very much the kindness of the "cast."

An automobile tour conducted by Mr. Meissner, President of the Merchants' Association of Lodi, was offered to the delegates on Sunday afternoon. The tour afforded the visitors an excellent opportunity to see our beautiful country, with which they were highly pleased.

Woodland-Lodi

The last interscholastic debate of the year was held in Woodland on May 2, between the teams of the Woodland and Lodi Union High Schools. Lodi was represented by Fern Dawson, Helen Limbaugh and Warren Gum; Woodland, by Eugene Stout, Shirley Schluer, and Borden Wood.



Oakdale 36, Lodi 26


