# SACRAMENTO CITY

\*

ACRAMENTO, the Capitol City of California and the County
Seat of government of the County, is located on an extensive plane at the confluence of the American and Sacramento Rivers, on the east bank of the latter stream which
flows along the west border of the County for about ninety
miles. From Sacramento the River is navigable for light
draught vessels as far north as Red Bluff, a distance of

about one hundred and thirty-five miles, while its chief tributaries, the American and the Feather, with their feeders, drain the extensive mining and timber regions of the Sierra Nevada Mountains.

The first American who effected a settlement on the present site of the City was the famous California pioneer, Capt. John A. Sutter, who built the celebrated Sutter Fort in 1840, and his name must stand paramount whenever an authentic history of Sacramento is given. A native of Switzerland, he had become a naturalized citizen of Mexico and received an immense grant of land conditionally—that he found and maintain a permanent colony. Up to 1844 the Fort of Capt. Sutter constituted the principal trading post in Upper California and was the only absorbing point of interest in the then Mexican territory. In the same year, Capt. Sutter, with others, endeavored to build up a town three miles distant from Fort Sutter—in fact a survey was made and a village laid out which grew and flourished under the name of Sutterville, until about the time of the gold discovery early in 1848. This discovery gave a new impulse to life and trade, as then followed the unprecedented rush of immigration that so quickly populated California and forced it into the American Union before it had passed the customary period of territorial probation.

In December, 1848, the City of Sacramento was surveyed and laid out by Capt. Wm H. Warner. The lesser needs of the village of Fort Sutter were now swallowed up in the greater needs of the City of Sacramento. In the mad rush for gold the fields were neglected. Capt. Sutter's company deserted him, his crops rotted for lack of harvesters, his property was swept away. Notwithstanding his loyalty and that through his generosity, the City of Sacramento came into possession of the strip of land lying between I and J, Ninth and Tenth Streets, known as the "Plaza," this noble soul passed away in comparative obscurity and poverty.

As proof of his sturdy republicanism and friendliness to his country, his Fort became the rallying point of the American, who, in 1846, had banded together as insurrectionists against the Mexican government. It was this little party of thirty-three men that captured the fortified town of Sonoma and struck the initial blow in the American conquest of the country. The most disastrous event which threatened the prosperity and permanency of Sacra-

mento was the great fire of 1852, which, on the second day of November swept away in a single night the results of many months of untiring labor. The energy of the young City, however, was not exhausted, but undaunted, it arose from the ruins in greater proportion than before. It was destined to receive another severe blow, for on the twentieth of December, 1852, it was fooded by a twenty-foot rise of the Sacramento River occasioned by heavy rains and the melting of the snow in the mountains, continuing thus until January 24th, 1853. Since that time, Sacramento has at different times suffered severely from fires, but the most serious calamity was the flood of 1861 and 1862, causing damage to the City estimated at three millions of dollars.

To-day, by that indomitable energy and perseverance which characterizes the American people, Sacramento stands as one of the most important and prosperous Cities of the Pacific Coast. It is the commercial, railroad and geographical center of Sacramento County, with an assessment roll of \$38,830,665 against \$37,180,623 of 1905. The City is thirty-one feet above the sea level. It is particularly well laid out, containing one hundred and forty miles of wide straight streets—the streets in the residence sections being beautifully shaded with arching trees and palms. There are numerous handsome parks, that in which the Capitol is located being especially fine, covering thirty-five acres and situated in the heart of the City, and containing trees, shrubs and flowering plants from all parts of the world—an interesting feature being a grove of trees brought from the principal battle fields of our Civil War.

The artistic taste of Sacramentans is exemplified in its beautiful homes made picturesque by velvety lawns, dotted with noble and rare trees of the tropics, the orange, umbrella and palm, side by side with the Camellia Japonica and others of colder zones.

Sacramento is justly proud of its Crocker Art Gallery, a private collection of paintings and statuary famed at home and abroad for its rarity. It is suitably housed in an imposing building, containing beside the gallery proper a spacious music hall and banquet rooms. This was the gift of the late Mrs. Margaret E. Crocker and her husband, the late Judge Edwin B. Crocker, and is one of the points of interest of the City.

The Southern Pacific is now the principal railroad and may be termed the pioneer line, the present Company having grown out of the Sacramento Valley road and the Central Pacific. Sacramento is liberally favored with transportation facilities, having railroads running in five directions: the Central Pacific leads to the East, the California and Oregon reaches into the northern part of the State and into Oregon and Washington, and the Weestern Pacific which connects between Sacramento and the South, and with the California Pacific, two routes to San Francisco.

The Northern Electric Company, a new addition to Sacramento's transportation facilities, serves the territory between Sacramento, Chico, Hamilton, Oroville and intervening points. Was opened for through business September 1, 1907. Operates several passenger and freight trains daily. Is to be extended to reach Vallejo, Woodland, west side of Sacramento Valley, north to Red Bluff and later to San Francisco.

The mean annual temperature for years past has been 60.5°; the highest

on any occasion was 104° and that only for a few hours in the day time, never interrupting work. It is a dry heat with rapid evaporation and free radiation and is more easily endured than 85° in the Eastern States. The nights are always cool. There is an average of two hundred and forty-four cloudless days in the year. During the winter or rainy season, from November to May, with the greatest precipitation in December, January and February, the temperature averages about 50°, and in December or January seldom falls below the freezing point of 32°.

Sacramento County, which ranks fifth among the Counties of the State, is located in the south end of the Valley, lying east of Solano and covers an area of nine hundred and sixty-eight miles or 619,520 acres, the surface being principally level, rising into hills to the eastward. The rich bottoms and lands of medium and fairly high elevation are watered by the Sacramento, American and Cosumne River and is an agricultural and fruit growing country, while there are in the neighborhood of twenty thousand acres of vineyards. In the eastern part citrus fruits and olive growing are important industries and show great development. Similar interests are rapidly increasing in other parts of the County. There are approximately seven hundred thousand fruit trees in the County and about eight thousand carloads of fresh fruits are shipped annually. The County ships ninety per cent of the fresh deciduous fruits shipped out of this State. In point of varied and abundant soil, Sacramento County fully holds her own with any other in the State, especially in the rare richness of the region immediately contiguous to the City. Florin, eight miles from the Capitol, is one of the greatest strawberry sections in the United States eleven hundred tons being shipped annually, representing a market value of over a hundred and thirty thousand dollars. The hop crop is valued at about nine hundred thousand dollars annually and ninety-two thousand carloads of grapes are shipped each year. The southern portion of the County is an important center for wine grapes and is showing great development in this industry. although some of the finest table grapes are also grown in this section.

The banking statements show more business than any other City of its size on the Pacific Coast, and are steadily increasing. The wholesale and retail merchants report a constantly growing trade. Last year was a banner building year in Sacramento, but the promise now is that the present one will eclipse in new buildings any year of the past. In two years more Sacramento will be the hub from which will radiate three great railroads, and this fact, together with the marvelous showing of the surrounding country, establishes the conviction that Sacramento will double in wealth and population before the national census is taken.

A great feature of the City is the Sacramento Chamber of Commerce, which, in fact, is the Sacramento Board of Trade, and which is alert to further every movement looking to the increasing prosperity of the City and Valley. With its climate, its beautiful location, its transportation facilities, and above all else, the wealth of the surrounding country, Sacramento is the most favored spot between the seas, and holds out more certain promise of progress than any other city between the Mississippi and the Pacific.
