General Information

The San Joaquin Valley District, California Federation of Women's Clubs, consisting of Fresno, Kern, Kings, Madera, Merced, Stanislaus and Tulare Counties, is one of the six districts which comprise our great California Federation of Women's Clubs, which in turn is a part of the General Federation of Women's Clubs, an international organization of women working for the betterment of humanity throughout the world.

The San Joaquin Valley District has 71 Federated clubs, total membership 4,932.

DUES

District dues of twenty (20) cents per capita, and State dues of twenty-five (25) cents per capita, payable on or before January 2nd of each club year, shall be paid to the District Treasurer.

County dues in accordance with the By-Laws of each County shall be payable to the Treasurer of such County.

For clubs belonging to the General Federation, dues of ten (10) cents per capita shall be payable to the General Federation Treasurer.

FEDERATION NEWS

The California Federation News is our official state magazine. Subscribe through your District Chairman of Federation News or direct to the office at Placentia, California.

Single subscriptions are 50 cents per year, or a 25-cent rate for 100% club subscription. Clubs of 250 or more membership, subscribing in blocks of 50, may receive the magazine at a 35-cent rate.

San Joaquin Valley District has the largest percentage of clubs subscribing 100%. Refer to the back of the Year Book for list of clubs listed as 100% subscribers.

This fund was begun in 1929 for the furtherance of Federation work. Each club member has been asked to give \$2.50 toward this fund, although it is not a compulsory obligation. One-half of this fund goes to the General Federation and one-half stays in the state. In California, the interest from this fund is added to the Endowment Fund interest to send speakers to the clubs.

San Joaquin Valley District has the largest percentage of clubs paid in full. Our goal is a 100% district.

Refer to the back of the Year Book for list of clubs paid up in full on this fund.

GENERAL FEDERATION

According to our State By-Laws, any club desiring to join any unit of our State Federation, either County, District or State, must automatically join the other two. "Universal Membership" would mean that every club in the State Federation would also become members of the General Federation, thus completing the entire chain of membership in the national organization of Women's Clubs. By having Universal Membership in the state, the dues in the General Federation are only 10 cents per capita.

California does not have Universal Membership. For this reason the state is required to pay to the General Federation 25 cents for every club belonging to the State Federation and not belonging to the General Federation. Another result is, a minimum number of 15 members and a minimum cost of \$2.50 per club per year as dues is set for any club desiring to join the General Federation. This means a per capita dues of more than 10 cents for any club under 25 members. As we have a number of clubs under 25, and even under 15, this means an added burden of dues in case they wish to join the General Federation.

Also, because the 10-cent per capita dues do not go as far toward taking care of necessary expenses now in these times of financial instability prevalent throughout the nation, as they did when first set, there is a possibility of the dues being raised unless more states have Universal Membership than the 11 now having it. Universal Membership is the worthwhile goal of our San Joaquin Valley District, as was voted at our 1940 Convention.

Procedure of Joining: When a club has voted to join the General Federation, the Secretary of that Club shall write to State Headquarters and advise them of the action of their club. Application for membership blanks will be sent the Club. These are to be filled out and signed by the proper designated officers, returned to the State and then forwarded to their proper destination by the State. Word will be sent the club by the General Federation of their acceptance, together with amount of dues required.

As a matter of courtesy, when a club votes to join the General Federation, notification should be sent the District Chairman of Federation Extension, who in turn notifies her State Chairman.

BY-LAWS

of the

Fresno County Federation of Women's Clubs

ARTICLE I

Name

The name of this organization shall be The Fresno County Federation of Women's Clubs.

ARTICLE II Object

The object of this Federation shall be to unite the influence and enterprise of the Women's Clubs of Fresno County, and to promote educational, moral, social and civic measures.

ARTICLE III Membership and Dues

Section 1. A club wishing to join the Fresno County Federation must become a member of the San Joaquin Valley District Federation. Such club then automatically becomes a member of this Federation.

Section 2. The annual dues of this Federation shall be Ter Cents (10c) per capita. Dues shall be paid thirty (30) days prior to the annual convention in March.

Section 3. Members of delinquent clubs may not vote on any issue at either Executive Board or County Federation meetings.

ARTICLE IV Officers and Executive Board

Section 1. The elective officers of this Federation shall be a President, two Vice-Presidents, a Recording Secretary and a Treasurer. The appointive officers shall be a Corresponding Secretary, Auditor and Parliamentarian.

Section 2. All officers must be members of clubs belonging to the Fresno County Federation and in good standing.

Section 3. Officers shall be elected biennially in March.

Page Thirty-four

Section 4. The officers, chairmen of departments, presidents of clubs, national, state and district officers and chairmen residing in Fresno County, and Junior Federation presidents residing in Fresno County shall constitute an Executive Board.

ARTICLE V

Duties of Officers and Executive Board

Section 1.

- (a) The County President shall preside at all meetings of the County Federation and of the Executive Board.
- (b) She or her appointee shall be the official representative of this Federation.
- (c) She shall appoint a Corresponding Secretary, an Auditor and a Parliamentarian.
- (d) With the approval of the Executive Board she shall appoint department heads and chairmen of committees.
- (e) She is a member ex-officio of all committees except the nominating committee.

Section 2. The Vice-Presidents in their order shall perform the duties of the President when she is unable to act. It is their duty to assist the President when called upon.

Section 3. The Recording Secretary shall keep the minutes of all meetings of the Federation and the Executive Board. She shall keep a roster of all clubs belonging to this Federation with the names and addresses of the president and recording secretary of each. She shall receive all moneys from clubs, give receipts for same and turn all funds over to the Treasurer, taking receipts therefor. At the request of the President or the Executive Board she shall issue notices, conduct correspondence and perform all other duties pertaining to her office.

Section 4. The Corresponding Secretary shall conduct such correspondence and issue such notices as are requested by the President or the Executive Board of this Federation.

Section 5. The Treasurer shall have charge of and safeguard all funds belonging to this Federation. She shall pay all bills vouched for by the President and Recording Secretary. She shall present an itemized report at the annual meeting.

Section 6. The Auditor shall audit all bills and records of this Federation and present her report to the Executive Board at the annual meeting in March of each year.

Section 7. The Parliamentarian shall perform the duties pertaining to her office and shall be chairman of the revision committee

Section 8. The Executive Board shall transact the business of the Federation and fill vacancies in offices occurring between elections.

ARTICLE VI

Departments and Committees

Section 1. The departments and committees of this Federation shall as far as possible conform to the outline submitted by the State Federation.

ARTICLE VII Meetings and Quorums

Section 1. The annual convention of this Federation shall be held in March, the time and place to be set by the Executive Board.

Section 2. The Executive Board shall hold four meetings each year, the time and place to be decided by the President.

Section 3. The call for the annual convention of this Federation shall be in the hands of clubs twenty (20) days prior to the day of convention.

Section 4. Special meetings of the Federation may be called upon the request of ten (10) clubs or at the discretion of the Executive Board.

Section 5. Special meetings of the Executive Board may be called upon the request of five (5) members or at the discretion of the County President.

Section 6.

- (a) Twenty-five (25) members representing at least ten (10) clubs shall constitute a quorum at the convention of this Federation or at a Federation meeting.
- (b) Seven (7) members shall constitute a quorum for an Executive Board meeting.

ARTICLE VIII

Elections and Nominations

Section 1. The election of officers of this Federation shall take place at the convention in March.

Section 2. No officer shall be eligible to the same office for more than two (2) consecutive years.

Section 3. Election shall be by written ballot, but if there is but one candidate for an office, the vote may be viva voce.

Section 4. A majority vote shall be necessary to elect.

Section 5. In case of election by written ballot the nominating committee shall serve as an election board.

Section 6. Officers shall be nominated as follows: At the regular Executive Board meeting preceding the convention in March, there shall be elected a nominating committee of five (5) members. The chairman of the nominating committee shall send a blank ballot to each Fresno County federated club. Clubs shall enter the names of candidates they endorse on these ballots and return them to the chairman of the nominating committee. With the aid of these ballots the nominating committee shall name a ticket to be submitted to the convention. If recommendations are not received the committee shall fill the list.

Section 7. Nominations for all offices may be made from the floor.

ARTICLE IX Representation

Section 1. All members of clubs belonging to this Federation are entitled to vote at the annual convention or other Federation meetings.

Section 2. Presidents of clubs or their appointees shall represent their clubs at all County Federation or Executive Board meetings.

ARTICLE X Budget and Expenses

Section 1. Immediately following the annual meeting the budget committee shall prepare the budget for the next year.

Section 2. No indebtedness shall be incurred in the name of this Federation unless authorized by the Executive Board.

Section 3. The President shall receive three cents (3c) per mile as traveling expenses in performing the duties of her office.

ARTICLE XI

Parliamentary Authority

Section 1. Roberts Rules of Order Revised shall be the authority in the conduct of all meetings.

ARTICLE XII Amendments

Section 1. These By-Laws may be amended at any regular meeting of this Federation by a two-thirds vote, notice of the proposed amendment having been given at the previous Executive Board meeting.

Section 2. By unanimous consent amendments may be submitted at the annual convention.

BY-LAWS

Kern County Federation of Women's Clubs

Revised and Approved at McFarland County Meeting February 9, 1940

ARTICLE I

The name of this organization shall be "The Kern County Federation of Women's Clubs".

ARTICLE II Object

The object shall be to unite the influence and enterprise of the Kern County clubs for effective cooperation within the county and within the District and State Federations for promoting educational, moral, social and civic enterprises.

ARTICLE III Membership

Section 1. The membership shall consist of every federated club in Kern County.

Section 2. A club in order to be eligible shall have been in existence at least three months and have a membership of not less than ten.

Section 3. Any club in the San Joaquin Valley District which joins the District Federation, automatically becomes a member of the County and State Federations also.

ARTICLE IV Officers and Executive Board

The officers shall consist of a President, Vice-President, Secretary, Treasurer, Parliamentarian and Auditor. These, together with the presidents of the federated clubs of the county, chairmen of departments, standing committees, and district and state chairmen and officers, and Past State and District officers residing within the county, shall constitute the Executive Board.

ARTICLE V Duties of Officers

Section 1. The President shall preside at all meetings of the Kern County Federation, all Executive Board meetings and shall appoint all chairmen of departments subject to the approval of the Executive Board. She shall be ex-officio a member of all committees

Section 2. In the absence of the President the Vice-President

shall perform all duties of the President.

Section 3. The Secretary shall keep a list of all clubs belong. ing to the Kern County Federation, keep records of all meetings and conduct all correspondence and issue such notices as are

required by the Executive Board.

Section 4. The Treasurer shall have charge of all funds belonging to the Kern County Federation and shall pay all bills that have been properly approved and for which warrants, signed by the President and Secretary, have been drawn. She shall present an itemized report at each county meeting.

Section 5. The Parliamentarian shall perform the duties pertaining to her office and shall be chairman of the revision com-

mittee.

Section 6. The Auditor shall audit the books of the Treasurer and make a yearly report at each annual meeting.

ARTICLE VI

Meetings

Section 1. There shall be no less than five regular meetings of the Executive Board, including the summer conference in June

Section 2. Special meetings may be called by the President or at the request of a majority of the clubs of the county. Announcements, in which the purpose of the meeting must be stated. shall be sent to each club.

Section 3. Notice of the date and place of the election of officers and of the annual meeting shall be sent to the clubs and to the press two weeks prior to these meetings.

ARTICLE VII

Nominations

Section 1. At the meeting prior to the election of officers, a nominating committee, composed of one member appointed by

the President and two members elected by the Executive Board. shall be elected. Each member of this committee shall be from a different club in the county.

Section 2. This nominating committee shall find those who will serve as President, Vice-President, Treasurer and Auditor, and shall present its report at the meeting at which the election is scheduled to take place.

ARTICLE VIII

Elections

Section 1. The President, Vice-President, Treasurer and Auditor shall be elected every two years at a regular meeting held at least two weeks before the district convention.

Section 2. Elections shall be by ballot, but the assembly, by unanimous consent, may dispense with the ballot when there is but one candidate for each office and the election may be by viva voce vote.

Section 3. The newly elected President shall appoint a Secretary, a Parliamentarian, and chairmen of departments. Announcements of these appointments shall be made at the annual meeting

Section 4. Eight members of the Executive Board shall con stitute a quorum for the transaction of business. At least five shall be representatives of different clubs.

Section 5. Newly elected officers shall enter upon their re

spective duties June 1st following the election.

Section 6. No elective officer shall be eligible to the same office for more than two consecutive years.

Section 7. A vacancy in any office shall be filled by the

Executive Board for the unexpired term.

Section 8. Every member of a federated club in the county in good standing shall be entitled to vote.

ARTICLE IX

Dues

The annual dues shall be 10 cents per capita, payable Novem ber 1st and shall become delinquent February 1st.

ARTICLE X

Reports

Yearly reports in writing shall be given by officers and chair men at the last meeting of the year.

BY-LAWS

of the

Kings County Federation of Women's Clubs

ARTICLE I

Name

The name of the organization shall be the Kings County Federation of Women's Clubs.

ARTICLE II

Object

The object of this organization shall be to cooperate with the General, State, and District Federations; to unite the influence and enterprise of the county federated clubs and to cooperate with other organizations within the county.

ARTICLE III

Membership

Section 1. Any organized women's group may be admitted to membership in the Kings County Federation of Women's Clubs by majority vote of the Executive Board. This membership implies membership in the District and State Federations.

ARTICLE IV

Officers

Section 1. The officers shall be President, Vice-President, Secretary-Treasurer, Auditor, Historian, and Parliamentarian.

Section 2. The Historian and Parliamentarian shall be appointed by the President. All other officers shall be elected by the Executive Board.

Section 3. These, with the member clubs in the county, chairmen of departments, chairmen of standing committees, district and state chairmen, and officers residing within the county, shall constitute the Executive Board.

Section 4. Seven members of the Executive Board, representing at least three member clubs, shall constitute a quorum.

Section 5. Vacancies in office shall be filled by the Executive Board.

ARTICLE V

Duties of Officers

Section 1. The President shall preside at all meetings, appoint such committees as are necessary and perform such other duties as pertain to her office. In the absence of the President, the Vice-President shall perform these duties.

Section 2. The Secretary Treasurer shall keep a list of all clubs belonging to the Federation, keep records of all meetings, conduct all correspondence, have charge of all funds, send annual notices to clubs for dues at the beginning of the year, giving receipts therefor, and issue such notices as are required by the Executive Board. She shall deposit in a bank, in the name of the County Federation, all monies, shall keep an itemized account of all receipts and expenditures and shall pay out all itemized bills approved by the Executive Board. She shall send notices of county meetings to all members of the Executive Board.

Section 3. Whenever deemed advisable, the President may appoint a corresponding secretary to assume those duties pertaining to that office.

Section 4. The Auditor shall audit all books of the Treasurer, audit all bills before payment, and render a written report at the annual convention.

Section 5. The Parliamentarian shall perform the duties pertaining to her office, and shall be chairman of Revision Committee.

Section 6. The Historian shall keep a log of the activities of the County Federation, and render an annual report to the State Historian.

ARTICLE VI

Section 1. The annual dues shall be fifteen cents per capita membership, payable at the call of the Treasurer, and delinquent after January first. Dues shall be based on the paid-up membership of each club as listed in the District Year Book.

Section 2. Delegates from clubs delinquent in payment of its dues shall not be entitled to vote at the annual convention.

ARTICLE VII Elections

Section 1. Elective officers shall be elected for a term of two years, beginning with the pre-biennial year. They shall be seated at the regular meeting in May.

Section 2. A nominating committee shall consist of one member from each club, appointed by the club president prior to the January meeting of the election year; they to elect their own chairman. The nominating committee shall serve as the election board.

Section 3. The report of the Nominating Committee shall be the first order of business at the March or annual meeting.

Further nominations may be made from the floor.

Section 4. Election of officers shall be by ballot, but if there is but one candidate for office, the Secretary or some member, by unanimous vote, may be instructed to cast the ballot for election. A majority vote shall elect.

Section 5. This committee shall meet at the call of the County President, at which time candidates' names for office shall be presented and a report be given at the January meeting prior to election in March

ARTICLE VIII

Department Chairmen

Section 1. The chairman of each department and division shall be appointed by the President, with the approval of the Executive Board, to serve for a term of two years, and shall become a member of the Executive Board upon such appointment.

ARTICLE IX

Voting Membership

Section 1. The voting membership shall consist of the County Federation officers, county chairmen, state and district officers and chairmen residing in the county, presidents of the federated clubs of the county, past presidents of the County Federation, and regularly named delegates or their alternates.

ARTICLE X

Meetings

Section 1. There shall be not less than three regular county meetings held annually, the time and place to be determined by the County Executive Board; preferably in October, January, and May.

Section 2. The Federation shall hold an annual convention at a time and place determined by the Executive Board, preferably

in early March. Such convention must be prior to the District Convention.

Section 3. Time and place of the annual convention shall be definitely stated in the call issued by the President on approval of the Executive Board. A copy of the call, signed by the President and Secretary, shall be mailed to each member club and to each member of the Executive Board at least fifteen days prior to the convention date.

Section 4. Special meetings of the Executive Board may be called by the President or at the written request of a majority of the member clubs in the county.

Section 5. Written notices of the Executive Board meetings and regular county meetings shall be mailed to each member club and to each member of the Executive Board at least one week prior to the meeting.

ARTICLE XI Representation

Section 1. Each club shall be entitled to be represented at the annual convention by its President or her appointee, and by one delegate. Clubs having a membership of twenty-five (25) or more shall be entitled to one delegate for every twenty-five (25) members or fraction thereof.

Section 2. No delegate shall represent more than one club Voting by proxy shall not be permitted.

ARTICLE XII

Budget-Ways and Means

Section 1. This committee shall be composed of the presidents of all member clubs, with the County President as ex-officion member.

Section 2. All financial policies shall be presented to the Budget Committee for consideration and recommendation before being acted upon by the County Executive Board.

ARTICLE XIII

Expenses of County President

Section 1. The County Federation shall allow expenses to the County President not to exceed Twenty-five dollars (\$25.00) for her use to the State Convention.

ARTICLE XIV Convention Committees

Section 1. The Convention Committee shall be Nominating,

Resolutions, Revisions, and Credentials.

Section 2. The Resolutions Committee shall consist of three members elected at the first county meeting of the year. This committee shall elect its own chairman. It shall be the duty of this committee to present in proper form to the annual convention, resolutions which have been endorsed by one federated club of the county.

Section 3. The Revisions Committee shall consist of the Parliamentarian, who shall be the chairman, and two others appointed by the President with the consent of the Executive Board. It shall be the duty of this committee to present amendments at the annual convention in such a manner as is set forth

under "Amendments".

Section 4. The Credentials Committee shall consist of a chairman who shall be a member of the club resident of the town where the convention is to be held, and two other members. All shall be appointed by the President with the consent of the Executive Board at least one month prior to the convention.

ARTICLE XV

Parliamentary Authority

Section 1. All meetings of the Federation shall be governed by Roberts Rules of Order.

ARTICLE XVI

Amendments

Section 1. These By-Laws may be amended at any annual convention by a two-thirds vote of those present who are entitled to vote. Proposed amendments shall be submitted in proper form and be appended to the call of the annual convention.

BY-LAWS

of the Madera County Federation of Women's Clubs

Name

This association shall be called "Madera County Federation" of Women's Clubs".

ARTICLE II Object

The object shall be to unite the influence and enterprise of the county clubs for effective cooperation within the county and with the District and State Federations:

ARTICLE III Membership

Section 1. Any club desiring to join this Federation shall make application in writing, accompanied by a copy of of its Constitution and By-Laws, with the name and address of its president and of its corresponding secretary, to the Corresponding Secretary of the Federation, who shall present the application to the Executive Board, and the club may be admitted by a majority vote.

Section 2. Any club applying for membership shall show by its Constitution that it requires no sectarian or political test for membership.

Section 3. Any club with a membership of both men and women may be admitted to the Federation, provided that the representation shall be upon the basis of the women membership.

Section 4. Any club may adopt its own policy and is in no way committed to work for measures voted for at county meetings such measures to be suggestive, not mandatory.

ARTICLE IV Officers

Section 1. The officers shall be President, Vice-President. Recording Secretary (Corresponding Secretary may be appointed

Section 4. No member shall be eligible to more than one elective office at a time.

ARTICLE V

Duties of Officers

Section 1. The President shall preside at all meetings, ap point such committees as are deemed necessary, appoint all chairmen of departments, perform such other duties as pertain to the office, and shall be ex-officio member of all committees except the nominating committee.

Section 2. In the absence of the President, the Vice-President shall perform all duties of the President.

Section 3. The Secretary shall keep a list of all clubs belong ing to the Federation, keep records of all meetings and perform such other duties as pertain to her office. She shall also conduct all correspondence and issue such notices as are required by the Executive Board and the President.

Section 4. The Treasurer shall have charge of the funds. notify clubs of indebtedness, receive dues, giving receipt for same, present a detailed report at each county meeting and an audited report of all receipts and disbursements at the annual meeting.

ARTICLE VI

Meetings

Section 1. At least three Executive Board meetings shall be held each year, at the call of the President.

Section 2. A general county meeting may be held in connection with any board meeting.

Section 3. An annual meeting shall be called by the President

on a date preceding the District Convention.

Section 4. Special meetings may be called by the President or at the request of a majority of the clubs of the county.

ARTICLE VII Delegates

Section 1. Each federated club shall be entitled to be represented at the annual meeting by its President or her appointee and one delegate for each 10 members or majorify fraction thereof.

Section 2. No delegate shall represent more than the one

club.

Section 3. Delegates from delinquent clubs shall not be seated.

ARTICLE VIII

Voting

Section 1. Each club representative shall have only one vote

Section 2. Voting by proxy shall not be permitted.

Section 3. A representation from three clubs shall constitute a quorum for transaction of business.

ARTICLE IX

Dues

Section 1. The annual dues shall be 15c per capita.

Section 2. Each club treasurer shall remit to the County Federation Treasurer at the beginning of each club year, October 1st, the annual dues of her club based upon the previous year's enrollment.

ARTICLE X

Elections

Section 1. All officers shall be elected by ballot at the annual meeting, except the Parliamentarian, who shall be appointed by the President.

Section 2. The Nominating Committee shall consist of five members, two of whom shall be appointed by the County Presi-

dent, two elected by the Executive Board and one chosen by these four. These shall be selected at the meeting preceding the annual meeting.

Section 3. It shall be the duty of the chairman of the Nominating Committee to send to each federated club of the county a copy of the report of this committee at least ten days prior to

the annual meeting.

Section 4. Nominations may be made from the floor, provided the consent of the nominee has been secured. If there be only one candidate for each office, the Secretary may be instructed to cast a unanimous ballot. At the annual meeting the Nominating Committee shall present its report. Further nominations may be made from the floor. When there is but one candidate for an office, then by unanimous vote the secretary or some other member may be instructed to cast the vote of the convention for that candidate

Section 5. A vacancy in any office shall be filled by the

Executive Board.

ARTICLE XI

These By-Laws may be amended at any meeting by two-thirds vote, providing the proposed amendment has been read at a previous meeting.

ARTICLE XII Parliamentary Authority

All meetings of the Federation shall be governed by "Roberts Rules of Order, Revised".

Approved by State Parliamentarian, February 10, 1934.

CONSTITUTION AND BY-LAWS

Merced County Federation of Women's Clubs

As Revised in 1936

ARTICLE I

Name

Section 1. The name of this organization shall be Merced County Federation of Women's Clubs.

ARTICLE II

Object

Section 1. The object shall be to promote better fellowship and encourage closer cooperation between the clubs for measures which affect county progress.

ARTICLE III Membership

Section 1. The membership shall consist of all federated clubs in Merced County.

ARTICLE IV

Officers

Section 1. The officers shall be President, First Vice-President, Second Vice-President, Secretary, Treasurer and two Auditors

ARTICLE V

Duties of Officers

Section 1. The President shall arrange for and preside at all meetings of the County Federation and over the meetings of the Executive Board; appoint all chairmen of departments subject to the approval of the Executive Board, and perform such other duties as pertain to the office.

Section 2. The First Vice-President shall preside in the absence of the President.

Section 3. In case of absence of the President and First Vice President, the Second Vice-President shall preside.

Page Seventy-three

Section 4. The Secretary shall keep a list of all clubs belonging to the Federation, take the minutes of each meeting, attend to all correspondence of the County Federation, and issue such notices as are required by the Executive Board and President.

Section 5. The Treasurer shall have charge of all funds of the County Federation and receive all moneys. She shall pay all bills when so ordered by the President and Secretary and present a financial report at the close of each Federation year.

Section 6. The Auditors shall audit the books once a year preferably at the last meeting before the end of the club year.

ARTICLE VI Executive Board

Section 1. The officers of the County Federation and the club presidents of the county shall constitute the Executive Board.

Section 2. The Executive Board shall transact all necessary business, ratify vacancies, and arrange for county meetings.

Section 3. Five members of the Executive Board shall con stitute a quorum. Two members shall be elected officers and at least three clubs shall be represented.

Section 4. There shall be at least one meeting of the Executive Board held in each club year.

ARTICLE VII

Meetings

Section 1. There shall be not less than two County Federation meetings each year called by the President, one in the Fall and the other in the Spring.

ARTICLE VIII

Quorum

Section 1. One-tenth of the membership of the County Federation shall constitute a quorum to transact business at any meeting.

ARTICLE IX

Dues

Section 1. The annual dues shall be ten cents per capita for each club.

Section 2. Dues shall be payable at the beginning of the club year and shall be delinquent after January first.

Section 3. Members from clubs delinquent shall not have

voting power.

Section 4. The use of the moneys from dues shall be decided by the Executive Board.

ARTICLE X

Voting

Section 1. The voting body at County Federation meetings shall be composed of the membership. No member shall represent more than one club.

ARTICLE XI

Nominating Committee

Section 1. At the county meeting preceding election, a nominating committee of five members shall be elected, two of whom shall be from the membership of the Executive Board and one representative from each federated club of the county.

Section 2. Each club of the County Federation shall be represented in the nominating committee. This committee shall elect

from its number a chairman.

ARTICLE XII

Elections

Section 1. The annual election of officers shall be held at the Spring meeting which shall take place prior to the district convention.

Section 2. Officers shall be elected for a term of two years the election to be held the same year as the district and state elections.

Section 3. The election shall be by ballot. The person receiving the greatest number of votes shall be declared elected.

Section 4. The newly-elected County President shall be presented and ratified by the District Convention.

ARTICLE XIII

Parliamentary Authority

Section 1. Robers Rules of Order shall be used as parlia mentary authority.

BY-LAWS

of the

Stanislaus County Federation of Women's Clubs

ARTICLE I

Name

Section 1. This association shall be called the Stanislaus County Federation of Women's Clubs.

ARTICLE II

Object

Section 1. Its object shall be cooperation between the several clubs of the county, and to promote general welfare amongst all

citizens of Stanislaus County.

Section 2. The Stanislaus County Federation of Women's Clubs shall meet the second Monday of each month, with the December meeting to be held in Modesto. No meetings to be held in July or August, unless especially called.

ARTICLE III Membership

Section 1. A club desiring to join the Stanislaus County Federation of Women's Clubs must be non-partisan, and its laws must not conflict with the by-laws of the county, district and state

Section 2. A club desiring to join the Stanislaus County Federation of Women's Clubs shall make application, accompanied by a copy of its Constitution and By-Laws.

Section 3. Clubs joining the Stanislaus County Federation must also become members of the District and State Federations

Section 4. Any club may be dropped from the Stanislaus County Federation of Women's Clubs by action of the membership in regular session for any reason which would have prevented its admission or for non-payment of dues.

ARTICLE IV

Officers

Section 1: The officers of this County Federation shall be: President, Vice-President-at-Large, and the president of each club

who shall be known as the Vice-Presidents, Recording Secretary, Corresponding Secretary, Treasurer, two Auditors, and Parliamentarian.

Section 2. No officer shall be eligible to the same office

for more than two consecutive years.

ARTICLE V

Duties

Section 1. The County President shall preside at all meetings of the County Federation. She shall appoint all chairmen, subject to ratification.

Section 2. In absence of the President, the Vice-President

shall perform the duties of the President.

Section 3. The Recording Secretary shall keep the minutes of all meetings and perform such other duties as are required by the President.

Section 4. The Corresponding Secretary shall conduct all

correspondence.

Section 5. The Treasurer shall receive all money for dues for the club and all money shall be banked in the name of the

Stanislaus County Federation of Women's Clubs.

She shall pay all bills that have been properly audited, and for which warrants have been drawn and signed by the Recording Secretary and President, and shall present in detail a report to the county meeting each month.

Section 6. The Auditor shall audit the Treasurer's books.

Section 7. The Parliamentarian shall perform the duties pertaining to her office, and shall be chairman of the Revision Committee.

ARTICLE VI

Elections

Section 1. All elections shall be by ballot for the term of two years, except the Corresponding Secretary and Parliamentarian, who shall be appointed by the President elect, subject to the ratification of the membership.

Section 2. Elections shall be held in the odd-numbered years Section 3. The Nominating Committee shall be composed of a membership of one member elected from each federated club in the county, and this committee shall elect its own chairman. Section 4. This committee shall meet in February and bring its report in at the regular February meeting.

Elections to be held in March and newly elected officers to

be installed in May.

ARTICLE VII

Dues

Section 1. Dues shall be 25c per capita, payable October 1, delinquent February 1.

Section 2. The expense of the President to the District Board meetings and State Convention shall be paid whenever funds permit

Section 3. A Budget Committee of three, the County President, Treasurer and one member appointed by President, subject to ratification. They shall make a budget at the beginning of each club year.

ARTICLE VIII

Section 1. A two thirds vote of the membership present at a regular meeting is needed to add to or change these by laws.

CONSTITUTION

OF

Tulare County Federation of Women's Clubs

Adopted February 12, 1940

ARTICLE I

Name

The name of this organization shall be the Tulare County Federation of Women's Clubs.

ARTICLE II

Object

The object of this organization shall be to cooperate with the State and District Federations; to unite the influence and enterprise of the county federated clubs; and to cooperate with other organizations acting for the general good of mankind.

ARTICLE III Membership

Section 1. The County Federation shall consist of all federated clubs in Tulare County.

Section 2. The voting membership shall consist of the County Federation officers, county chairmen, district officers and chairmen residing in the county, presidents of the federated clubs of the county, past presidents of the County Federation and regularly named delegates or their alternates.

ARTICLE IV Officers

Section 1. Elective officers shall be President, Vice-President, Recording Secretary, Treasurer and Auditor.

Appointive officers shall be Corresponding Secretary and Parliamentarian.

Section 2. The officers, the president of each federated club in the county, county chairmen, officers and chairmen of the dis trict residing in the county and past presidents of the County Federation shall constitute the Executive Board, of which the President of the district shall be ex-officio member at all times.

ARTICLE V

Elections

Section 1. Officers shall be elected at the annual convention in odd-numbered years, for a term of two years. No officer shall be eligible to the same office for more than two consecutive years. Officers shall be seated at the last regular meeting of the year.

Section 2. Election shall be by ballot except where there is but one candidate for an office, the law requiring a ballot may be suspended and the vote taken by viva voce (or voice).

Section 3. Appointive officers shall be appointed by the President.

Section 4. Nominations for officers shall be made by the Nominating Committee, who shall report at the first meeting after the first of January of the election year. Further nominations from the floor may be made on date of election.

ARTICLE VI Meetings

Section 1. The Federation shall hold an annual convention at a place and time determined by the County Executive Board Such convention must be held prior to the District Convention.

Section 2. There shall be not less than three regular county meetings. Time and place shall be designated by the President.

Section 3. The Executive Board may hold a winter and summer conference, at which time plans and policies shall be discussed and acted upon. Time and place of these meetings shall be designated by the President.

Section 4. Special meetings of the Executive Board may be held upon the call of the President or at the written request of the majority clubs in the county, provided a three days' written notice is sent to each member club and each member of the Executive Board.

Section 5. Time and place of the convention shall be definitely stated in the Call issued by the President on approval of the Executive Board. A copy of each Call, signed by the President and one of the Secretaries, shall be mailed to each member club

and each member of the Executive Board at least one month prior to the time of convening.

Section 6. Written notices of the Executive Board meetings and county meetings shall be mailed to each member club and each member of the Board at least one week prior to the meeting

ARTICLE VII

Duties

Section 1. The President shall preside at all meetings of the Tulare County Federation and all Executive Board meetings. She shall appoint all chairmen of departments subject to the approval of the Board. She shall appoint the Corresponding Secretary and the Parliamentarian and such committees as may be necessary.

Section 2. The Vice-President shall perform all the duties of

the President in her absence.

Section 3. The Recording Secretary shall keep a list of all clubs belonging to the County Federation and shall keep a record of all annual, special, and regular meetings of the County Federation and the Executive Board.

Section 4. The Corresponding Secretary shall conduct all correspondence of the County Federation, shall keep a correct list of all clubs belonging thereto, the chairmen of departments and of special and standing committees. She shall, with the President.

sign all warrants.

Section 5. The Treasurer shall have charge of all funds belonging to the County Federation and shall send out annual notices of club dues at the beginning of each club year. She shall receive all dues from clubs and give receipts therefor. She shall pay all bills signed by the President and Secretary and present an itemized report at the annual convention.

Section 6. The Auditor shall audit the books of the Treasurer and present a written report at the last meeting of the year.

Section 7. The Parliamentarian shall perform the duties pertaining to her office and shall be chairman of the revisions committee.

ARTICLE VIII Dues

The yearly dues shall be ten (10) cents per capita, payable at the beginning of the club year and delinquent after January first Page Ninety-two

Delegates from clubs delinquent in payment of its dues shall not be entitled to vote at the annual convention. Dues shall be based on the number of members listed in the District Year Book.

ARTICLE IX

Convention Committees

Section 1. The convention committees shall be nominating, resolutions, revisions and credentials.

Section 2. A nominating committee composed of one member from each federated club in the county shall be elected before November first of the election year by the respective clubs. The nominating committee shall elect its own chairman. This committee shall meet at the call of the County President at which time candidates' names for offices shall be presented. This committee shall report at the first meeting after the first of January of the election year.

Section 3. The Resolutions Committee shall consist of three members elected at the first county meeting of the club year. This committee shall elect its own chairman. It shall be the duty of this committee to present in proper form to the annual convention resolutions which have been endorsed by one federated club of the county or signed by delegates representing at least seven federated clubs of the county.

Section 4. The Revisions Committee shall consist of the Parliamentarian, who shall be chairman, and two others appointed by the President with the consent of the Executive Board. It shall be the duty of this committee to present amendments at the annual convention in such manner as is set forth under amendments.

Section 5. The Credentials Committee shall consist of a chairman who shall be a member of the club resident of the town where the convention is to be held and two other members. All shall be appointed by the President with the consent of the Executive Board at least one month prior to the convention.

ARTICLE X

Representation

Section 1. Each club shall be entitled to be represented at the annual convention by its President or her appointee and by one delegate. Clubs having a membership of twenty-five (25) or more shall be entitled to one delegate for every twenty-five (25) members or fraction thereof.

Section 2. No delegate shall represent more than one club

Voting by proxy shall not be permitted.

Section 3. The secretary of each club shall certify to the Credentials Committee one week prior to the convention the names of the delegates and alternates from her club.

ARTICLE XI

Vacancies

Vacancies in an elective office may be filled by election at any regular or special meeting of the Board.

ARTICLE XII

Quorum

Section 1. Seven members of the Executive Board shall constitute a quorum at all regular and convention meetings, provided that representation is from five clubs.

Section 2. Eleven members of the Executive Board shall constitute a quorum at all called and special meetings provided repre

sentation is from three clubs.

ARTICLE XIII

Budget Committee

Section 1. The Budget Committee shall be composed of the

Treasurer, Corresponding Secretary and the President.

Section 2. All financial policies shall be presented to the Budget Committee for consideration and recommendation before being acted upon by the County Executive Board.

ARTICLE XIV

Amendments

Section 1. The Constitution and By-Laws may be amended at the annual convention by a two-thirds vote of the regularly elected delegates who are present and voting. Proposed amend ments shall be presented to the convention by the Revisions Committee.

Section 2. All amendments shall be submitted to the member clubs at least one month before the convention.

ARTICLE XV

Robert's Rules of Order, Revised, shall govern all proceedings at the meetings.

CONSTITUTION AND BY-LAWS

San Joaquin Valley District Federation

ARTICLE I

Name and Annual Convention

Section 1. This Association shall be called the San Joaquin Valley District, California Federation of Women's Clubs.

Section 2. The San Joaquin Valley District, California Federation of Women's Clubs, shall hold an Annual Convention.

ARTICLE II Object

Its object shall be to promote the interests and unite the influence and enterprise of the Federated Women's Clubs of this District, to receive at Executive Board and annual convention the reports of the clubs of the District, the chairmen of departments and chairmen of standing committees and the officers of the Federation; and to pass upon such matters as shall come before the Association for consideration.

ARTICLE III

Procedure for Joining California Federation of Women's Clubs

Section 1. A club desiring to join the Federation shall make application accompanied by a copy of its Constitution and By-Laws, with the names and addresses of its officers to the District Chairman of Federation Extension, who shall present its credentials to the State Chairman of Federation Extension.

Section 2. Clubs applying for membership shall show by their Constitution that the organization requires no sectarian or political tests for membership; and that it will not conflict with the By-Laws of the District or State Federations.

Section 3. Any club may be dropped from the District Federation by action of the District Executive Board for any reason which would have prevented its admission, or for non-payment of dues.

Section 4. Similar clubs of men and women are eligible upon the same condition as a women's club, provided representation
